7. Bids shall be opened in presence of Bidders' representatives who choose to attend on **14:00 Hour on 2077/03/26 (10 July 2020) at District Hospital, Bajhang.**
8. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security which shall be valid for minimum 30 days beyond the validity period.
9. If the last date of submission and opening falls government holiday then the next working day shall be considered the last day of submission. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
10. Any discrepancies or error in the bid document, bid notice or any other document will be as per PPA & PPR and other Nepal Law; and the Office of District Hospital, Bajhang reserves the right to amend and correct at any time.
11. The contract has been divided into 2 (two) packages. Bidder may submit the bid for single or both package and offer discounts/cross discounts. Evaluation will be done Package by package basis, only the total items quoted will be considered as the bid amount.
